SETTLEMENT AWARD

1. The present DAR is in respect of compensation regarding injuries suffered by the injured, namely, Mamta Kulratn @ Kulratan in the accident which took place on 31.07.2023.
2. The parties have amicably settled the matter before the Mediation Center for a sum of Rs.5,50,000/- to be paid by the Respondents to the petitioner towards full and final compensation for indemnifying the driver and owner of the offending vehicle.
3. As per the settlement, it has been agreed between the parties that the settlement amount of Rs.5,50,000/- shall be paid in five installments of Rs.1,10,000/- each on every 10th day of English calendar month starting from August 2026 till December 2026 by way of RTGS/NEFT/Cash/Online modes etc. in the account of the petitioner as mentioned in the Mediation Settlement and in case of default/delay in payment of installment/settlement amount, the respondent shall be liable to pay the interest @ 12% per annum on the defaulted installment/ amount for the defaulted period.
4. The statements of the Petitioner and Mr. Ajay Arora, Director of Respondent No. 2 reaffirming the settlement are already on record.
5. The amount agreed between the parties is just and reasonable in the facts and circumstances of the case and accordingly, an Award of **Rs. 5,50,000/-(Rupees Five Lakhs Fifty Thousand Only)** is hereby passed in favour of the Petitioner against the Respondents in full and final

settlement of claim of the Petitioner against the Respondents.

6. The award amount shall be payable by **Respondent No. 2** to the Petitioner as per the terms and conditions mentioned in the mediation settlement.

7. An attested copy of the award be given to both parties for compliance.

8. File be consigned to Record Room after completion of necessary formalities as per rules.
