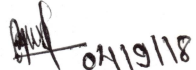

JUDGMENT

(Delivered on 04th day of September, 2018)

The accused voluntarily plead guilty. Therefore, the accused is liable to be convicted. The accused submits that he is only earning member of his family. He further submits that this is his first offence. Therefore, the accused prayed for leniency. Considering submissions of the accused, in my view, lenient view will have to be taken. Hence, I pass the order :-

ORDER

The accused namely Mohammad Babalu Abdul Shaikh, R/o.: Lal Mitti, Nargis Das Nagar, Inside Bridge, Bandra (W), Mumbai is convicted for the offence in contravention of the section 8 (c) punishable under section 27 of the Narcotic Drugs Psychotropic Substances Act, 1985 vide section 252 of the Code of Criminal Procedure and he is sentenced to suffer simple imprisonment for 07 (Seven) days and pay fine of Rs. 100/- (One Hundred) and in default of payment of fine the accused shall further suffer simple imprisonment for 03 (Three) days.
