CLAIM: The plaintiff humbly prays this Hon'ble court to pass a judgment and decree in favour of the plaintiff against the defendants for the following reliefs :

- a) For the recovery of the said sum of ₹1,03,083-00/- with current interest 10.50% p.a., compounded monthly and also penal interests at the rate of 5% p.a from 01.07.2024 till realisation with costs personally from the defendants.
- b) For such other and further reliefs as this Hon'ble Court deems fit to grant under the circumstances of the suit, in ends of justice.

This suit is coming on this day for final disposal before **Smt. Suraksha K.K., B.B.M. LLB., I Addl. Civil Judge & JMFC., Mudigere**, in the presence of **Sri.G.B.Venkatesh**, Advocate for the **Plaintiff** and **Sri. B.N. Vaishaka**, Advocate for **defendant No.1 and defendant No.2 dead and 2(a) & 3** placed exparte.

By pronouncing exparte judgment, it is ordered and decreed that **the suit of the plaintiff bank is hereby decreed with costs against the defendant No.1 and 2(a).**

It is further ordered and decreed that the defendant No.1 and 2(a) are hereby directed to pay a sum of ₹1,03,083/- to the plaintiff bank along with interest @ 6% p.a. compounded monthly from the date of suit till the date of decree till realization.
