

Accused No.1 to 6 are present. Learned counsel Sri.M.V.J, files vakalath for accused No.1 to 6 along with bail application U/sec.478 of BNSS, praying to enlarge the accused No.1 to 6 on bail for offences P/u/s.115(2), 352 and 329(4) R/w 190 of BNS.

2. In the bail application, it is contended that the accused No.1 to 6 are innocent and not committed any offences as alleged, they are not an influential persons to tamper the prosecution witness and ready to abide by the conditions imposed by this Court. Accused No.1 to 6 also undertakes to appear before the Court whenever directed to do so. With these averments, it is prayed for enlarging the said accused No.1 to 6 on bail.

3. On perusal of materials on record, it is evident that the offences alleged against the accused No.1 to 6 is punishable P/u/s.115(2), 352 and 329(4) R/w 190 of BNS, which are bailable in nature and triable by this Court. Accused No.1 to 6 are further ready to offer surety for appearance before the Court. Hence, having regard to the nature and gravity of the offences alleged against the accused No.1 to 6, this Court is of consideration that there should not be any legal hurdle to enlarge the accused No.1 to 6 on bail. Therefore, this Court considers to release the accused No.1 to 6 on bail by imposing conditions so as to safeguard the apprehensions of prosecution. Hence, the following:

ORDER

Accused No.1 to 6 are released on bail subject to following conditions.

CONDITIONS

- 1) Accused No.1 to 6 shall execute a personal bond for a sum of Rs.50,000/- each with one surety for likesum.
- 2) Accused No.1 to 6 shall not commit similar offences in future.
- 3) Accused No.1 to 6 shall appear before this Court on all the dates of hearing regularly, without fail.
- 4) Accused No.1 to 6 shall not threaten the prosecution witnesses or tamper with the prosecution material;
