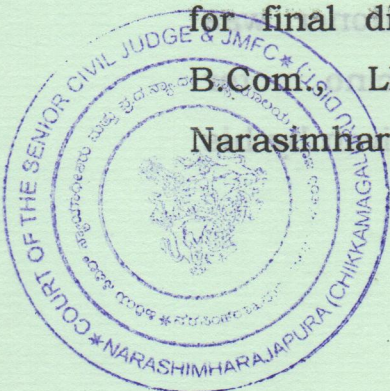
**PETITION FILED ON 08.01.2024**

**CLAIM:** The claim is for compensation of Rs.13,00,000/- from the respondents on the ground that on 03.06.2023 at about 6-00 p.m the petitioner was proceeding as a pillion rider in Yamaha Fascino motor cycle bearing registration No.KA.18/ED9072 driven by his



father Sri.Mustafa from Koppa Town to Jogisara. While they were proceeding so, slowly, cautiously near Breeze Hotel, Balagadi road, Koppa Town. The respondent No.1 being the rider of Maruthi Alto car bearing registration No.KA.18/N6562, drove the said car with a rash and negligent manner and suddenly entered into the main road and dashed the scooter in which the petitioner and his father were proceeding. Due to said accident the petitioner and his father fell down and sustained injuries. The petitioner has sustained grievous injuries as follows: (a) swelling deformity was present involving the distal part of right fore arm and wrist, with associated pain and tenderness, (b) Selling deformity was present involving the mid part of left thigh, with associated pain and tenderness, with underlying fracture of femur bone. Immediately after the accident the petitioner was shifted to Government Hospital, Koppa, and then where the petitioner has taken treatment as an inpatient. The 1<sup>st</sup> respondent being the driver-cum-owner of Maruthi Alto car bearing registration No.KA.18/N6562, the 2<sup>nd</sup> respondent is the insurer.

This petition coming on this 07<sup>th</sup> day of March, 2026 for final disposal before Sri.Raghunatha Gowda K.T., B.Com., LLB., Senior Civil Judge & M.A.C.T at Narasimharajapura, Itinerate at Koppa in presence of





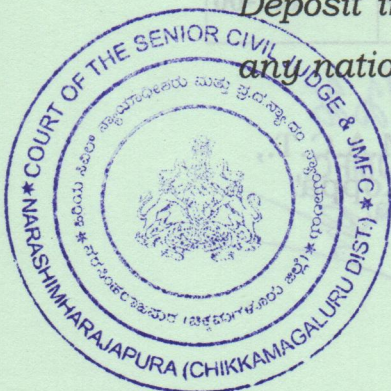

After contest and by pronouncing judgment, it is ordered and decreed that, the claim petition filed by the petitioner under Section 166 of M.V. Act, is hereby partly allowed with cost.

It is further ordered and decreed that, the petitioner is hereby entitled for compensation of Rs.5,26,813/- with interest at the rate of 8% p.a from the date of petition till its realization.

It is further ordered and decreed that, the respondent No.2 is hereby directed to deposit the entire compensation amount with interest within a period of 30 days from the date of this order to the petitioner account directly and submit a compliance report to this court.

It is further ordered and decreed that, out of the compensation 50% amount to be released in favour of petitioner and remaining 50% amount shall be kept in Fixed Deposit in the name of petitioner for a period of 3 years in any nationalized bank.





It is further ordered and decreed that, the respondent No.2 is hereby directed to deposit Rs.5,030/- to the petitioner towards cost of the petition.
