**PETITION FILED ON 08.04.2025**

**CLAIM:** The claim is for compensation of Rs.30,00,000/- from the respondents on the ground that on 24.10.2023 at about 3-30 p.m. when the



petitioner was going to his farm house in his Motorcycle bearing registration No.KA.18 – S.3257 slowly, cautiously by observing all the traffic rules, when the petitioner reached in front of Hanthuvani Dayananda Farm House in Shanthibhavan to Saluru Road, the respondent No.1 being the driver of Maruthi Car bearing registration No.KA.03 – MK.5103 from opposite direction in rash and negligent manner dashed motorcycle in which the petitioner was proceeding. Due to the accident petitioner fell down sustained injuries to his right hand and left leg. Immediately, after the accident the petitioner was shifted to Government Hospital, N.R.Pura and then shifted to Nanjappa Healthcare Hospital, at Shimoga, where the petitioner has taken the treatment as an inpatient. The 1<sup>st</sup> respondent being the driver and 2<sup>nd</sup> respondent being the owner of Maruthi Car bearing registration No.KA.03 – MK.5103, the 3<sup>rd</sup> respondent is the insurer.

This petition coming on this 25<sup>th</sup> day of March, 2026 for final disposal before Sri.Raghunatha Gowda K.T.,, B.Com., LLB., Senior Civil Judge & M.A.C.T at Narasimharajapura. in presence of Sri.Vidwath G., Advocate for the petitioner and Sri.K.P.Sureshkumar, Advocate for respondent No.1, Sri.S.R.Srikanth, Advocate for 3<sup>rd</sup> respondent, respondent No.2 is placed Ex-parte.



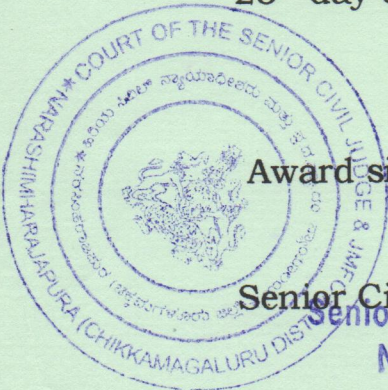

It is further ordered and decreed that, the respondent No.3 is hereby directed to deposit the entire compensation amount with interest within a period of 30 days from the date of this order to the petitioner account directly and submit a compliance report to this court.

It is further ordered and decreed that, the respondent No.3 is hereby directed to deposit Rs.4,025/- to the petitioner towards cost of the petition.


