उलटतपासाकरीता गैरअर्जदारतर्फे विधीज्ञ श्री. मनीष देशराज यांच्यामार्फत सुरु -

My marriage was arranged and solemnized on 30.10.2019 at Nagpur. I have not produced list of articles, which give to non-applicant at the time of marriage. When my mother-in-law and sister-in-law have tortured me mentally and physically, I have filed complaint against them at Police Station. I have filed that complaint on record. Now record shown to me. According to me, the complaint of torture is filed at Exh.29 and Exh.30. I have also not filed on record the bills of articles given to non-applicant in form of Dahej. It is not true that my husband is heavy drunken and he create chaos.

After marriage I live with non-applicant only for two months under one roof. Thereafter I shifted on first floor of same house. I have not shifted in rented house as it was Corona period, I was pregnant and we have not enough amount for rent also my husband was jobless. When I was started resided on first floor the torture and harassment by non-applicant was still going on.

My parents have given Sofa set, TV, Gas, Utensils, cash amount of Rs.1,00,000/- to non-applicant as Dahej in my marriage. My mother-in-law asked me to bring golden ornaments from my parents. At present my mother-in-law was not residing on ground floor. The house wherein I reside with my husband is in name of my mother-in-law. It is not true to say that I started to make story of

domestic violence since the date my mother-in-law has transferred the property in name of my sister-in-law.

My parents have bear expenses of Rs.1,00,000/- to Rs.1,50,000/- in my marriage. After assault by non-applicant No.1, I have done my medical examination. I have no idea that non-applicant No.1 has purchased a plot in name of my husband. I have also no idea that after retirement non-applicant No.1 has purchased two plots, one in name of my husband and other is in name of non-applicant No.2. It is not true to say that my husband has purchased plot of non-applicant No.2 without any consideration under the pretext of getting loan. I have mentioned the name of witnesses who has witnessed the domestic violence by non-applicant on me. Name of those witnesses are Pramod Patil, Sagar Waikar, Wankhede, Besikar, Seem Dhoke.

At present my husband is working in office of New India Health Insurance. He works as Insurance Investigator. I am also working in Pathology and collect the samples. It is not true to say that I have filed present application only with intention to grab the property of non-applicant No.1 and 2. It is not true to say that I have deposed false.
