**: COMMITTAL ORDERS U/Sec. 232 of B.N.S.S. :**

3. On perusal of the police report, it is evident that, the offence alleged against accused No.1 to 4 punishable U/Sec.311 of B.N.S. is exclusively triable by Hon'ble Court of Sessions. Hence, the case against the accused persons to be committed to



the Hon'ble Sessions Court, Chikkamagaluru. Hence, the following;

**: O R D E R :**

The case against the accused No.1 to 4 are hereby committed to the Hon'ble Prl. District and Sessions Judge, Chikkamagaluru U/Sec.232 of B.N.S.S. for trial.

The copy of the charge sheet and other prosecution papers have been furnished to the counsel for accused No.1 to 4 as required U/Sec.230 of B.N.S.S.

Accused No.1 to 4 are in J.C. directed the Jail Authority, Chikkamagaluru to produce the accused persons before the Hon'ble Prl. District and Sessions Judge, Chikkamagaluru whenever called upon by the said court.

Office is directed to submit the entire records of the case to the Hon'ble Prl. District and Sessions Judge, Chikkamagaluru forthwith and the case



properties if any shall be submitted, as and when called for by the said court.

Office is directed to notify the Public Prosecutor, Chikkamagaluru regarding the committal of the case to the Hon'ble Sessions Court.
