Matter is listed today for appearance of accused persons/further proceedings.

It is stated by Sh. M. S. Bammi, Ld. counsel that he has been recently engaged by accused Satwinder Singh Purewal and Ld. counsel seeks some time to move bail application on behalf of accused Satwinder Singh Purewal on the NDOH. Heard. Allowed.

Ld. counsels for accused Navjot Singh, Chetan Sharma, Harpreet Singh Devgun and Ashok Kumar Singh have filed applications seeking grant of regular bail. Copy of the same supplied to the prosecution.

The applications are orally contested by Ld. PP for the CBI. It is stated by Ld. PP for the CBI that he has no objection in allowing the present bail applications filed by the accused Navjot Singh, Chetan Sharma, Harpreet Singh Devgun and Ashok Kumar Singh.

Arguments on the bail applications have been heard.

Perusal of the file reveals that accused Navjot Singh, Chetan Sharma, Harpreet Singh Devgun and Ashok Kumar Singh were not arrested during the investigation. Charge sheet has already been filed. No purpose will be served by detaining them in custody at **this stage. Therefore, in view of the aforesaid facts and circumstances, accused are admitted to bail on furnishing of their personal bonds in the sum of Rs. 25,000/- with one surety in the like amount subject to the conditions that: -**

- (i) accused/applicants shall not indulge in the offence/s of the same nature.
- (ii) accused/applicants shall not influence the witness/s and shall join the further investigation and appear in the court as and when directed to do so by the authorities concerned.
- (iii) accused/applicants shall not hamper with the further investigation, if any, in any manner.
- (iv) accused/applicants shall not leave India without prior permission of this court.

Bail applications stand disposed of.

Requisite bonds on behalf of accused Chetan Sharma, Harpreet Singh Devgun and Ashok Kumar Singh have been furnished. The same are considered and accepted. Original FDRs/stamped copy of online FDRs be retained on record. Concerned banks be intimated and directed to mark a lien on the said FDRs and file a compliance report before the court.

Soft copy of charge-sheet alongwith accompanying documents have been supplied to Ld. counsels for A-2, A-4 and A-5 in the court against proper acknowledgment except A-1 and A-3. Additional copy of the same for A- and A-3 has been re-

tained on record and they are at liberty to take the same from concerned Ahlmad against proper acknowledgment as per rules. Hard copy of the charge-sheet and accompanying documents would be supplied on the NDOH.

Put up for filing of bail application on behalf of accused Satwinder Singh Purewal/bail bonds on behalf of accused Navjot Singh/scrutiny of documents on **20.05.2026**.
