**STATEMENT OF ACCUSED UNDER SECTION 313 OF CODE OF
CRIMINAL PROCEDURE 1973.**

Q. No. 1 : Have you gone through/ heard the evidence?

Q. No. 2 : PW-1/ Mr. Santhosh, CEO, has stated in his chief examination that you Accused are a member of the Complainant Institution. On 12.01.2016 you the Accused have borrowed Rs.40,000/- from the institution for the

purpose of development of lands, agreeing to repay the said loan amount in 24 monthly installments with interest at 16% p.a. and towards the said loan One Sri Prakash R has stood as guarantor. You the Accused have failed to repay the loan despite of repeated reminders. Thereafter, on 13.12.2021 you the Accused have issued a cheque bearing No. 141095, dated 13.12.2021 for a sum of Rs.77,158/- drawn on your bank account held with Vijaya Bank, Sringeri branch towards the discharge of the debt. What do you say?

Q. No. 3 : PW -1 has further stated that, on presenting the cheque, it was dishonoured for “**Funds in sufficient**”. What do you say?

Ans. : False.

Q. No. 4 : PW-1 has further stated that inspite of issuance of demand notice to you, you have failed to repay the same within the statutory period and thereby committed an offence punishable U/Sec. 138 of N.I. Act. What do you say?

Ans. : False.

Q. No. 5 : Have you got anything to say regarding the evidence adduced against you?

Ans. : Not at this moment.

Q. No. 6 : Have you got any defense evidence?

Ans. : Yes.
