JUDGMENT
[Delivered on 17/8 / 2026]

1. The accused stand prosecuted for the offence punishable u/Sec. 285 of BNS. The particulars of the offence read over and explained to the accused. The accused pleaded guilty for the same by application and prayed for mercy.

ORDER

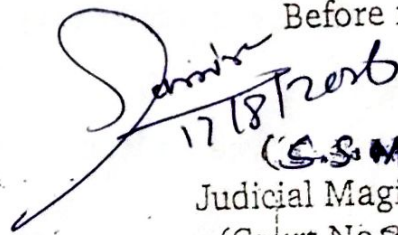

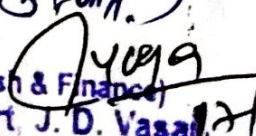
