Kumar Gaurav v. Unknown.

Fresh DAR filed today. It be checked and registered as per rules.

Present : Injured Kumar Gaurav is present in person.
IO ASI Ram Awatar is present.

DAR has been filed in respect of the present FIR and it is stated that there are two injured, namely, Kumar Gaurav and Sujit Gupta.

The Ahlmad is directed to register the DAR separately in respect of each injured and the present DAR shall be considered in respect of the injured Kumar Gaurav.

Copy of DAR has been supplied to the injured today.

It is submitted by the IO that the untrace report is in respect of the FIR No. 466/25, PS Civil Lines, under Section 281/125(b) BNS, which is in respect of a hit and run accident and the offending vehicle could not be traced despite best efforts. He further submits that untrace report has already been filed before Ld. JMFC-06, Central District, Tis Hazari Courts, wherein the statement of the injured was recorded, the untrace report was accepted and the file was consigned to the police Record Room with directions to be revived as and when any clue about the case is found. He has also filed copy of order dated 17.01.2026, passed by Ld. JMFC-06, Central District, Tis Hazari Courts, Delhi.

The injured submits that he has gone through the DAR and he does not wish to file any protest petition in respect of the DAR as filed, since he is satisfied with the investigation carried out in the hit and run accident and he does not have any information about the registration number of the offending vehicle or about the identity of its driver as both are unknown.

Separate statement of the injured has been recorded in respect of the same.

Heard. Record perused.

Untrace report is stated to have already been accepted by the Court of Ld. JMFC-06, Central District, Tis Hazari Courts on 17.01.2026. The *dasti* copy of the said order has also been filed by the IO in MACT No. 52/26.

In view of statement of the injured and also considering the fact that the untrace report has already been accepted by Ld. JMFC-06, in view of the relevant material filed along with the DAR as per which the driver and owner of the offending vehicle are unknown, the DAR as filed is accepted as untraced.

File be consigned to the Record Room as sine-die. It be revived as and when the whereabouts of the driver and owner of the offending vehicle are traced.

Injured has been informed about the Victim Compensation Scheme. Injured is at liberty to approach the office of DLSA (Central), at Room No. 287, Tis Hazari Courts, Delhi for compensation as per rules.

On request, copy of this order be given *dasti*.

Ahlmad is directed to send a copy of this order to the Office of the DLSA (Central) at Room No. 287, for intimation.

Copy of this order be placed in MACT No. 53/26, being the connected matter.
