APPLICATION FOR GRANT OF LEGAL HEIRSHIP CERTIFICATE.

FINAL ORDER BELOW EXH.1

(Passed on 01st of August, 2026)

The applicants, named above, have moved this application

under Bombay Regulation Act for grant of legal heirship certificate in their name.

2. The case of the applicants, in short, is that:-

The applicant no. 1 is the widow and applicant no. 2 is the son and applicant no. 3 and 4 are the daughters of deceased Dattatray Damaji Kove, who died on 09.04.2026 at Shankarrao Chavhan Medical College Vishnupuri, Nanded, Ta. Dist. Nanded.

3. Deceased Dattatray Damaji Kove, was permanent resident of Parwa, Ta. Ghatanji, hence this Court has jurisdiction to try and decide the application.

4. Deceased Dattatray Damaji Kove, after his death, has left behind him the present applicants as his Class I legal heirs. Besides applicants, there is no other legal heirs of deceased Dattatray Damaji Kove. The applicants being the legal heirs of deceased Dattatray Damaji Kove, are entitled for their legal heirship certificate. The applicants are in need of legal heirship certificate for official purpose.

5. In view of this application, due publication was made in the local newspaper i.e. "Matrubhumi". The report of publication is filed on record. So also, the newspaper is filed on record. Present application is supported by an affidavit. Apart from this, the applicants have also filed on record the certified copy of death certificate of deceased Dattatray Damaji Kove and copies of their respective Adhar cards. All the documents probabalise the claim of applicants that they are the only legal heirs of deceased Dattatray Damaji Kove. Apart from this, no one has claimed to be the legal heirs

of deceased Dattatray Damaji Kove, after publication of public notice in the concerned newspaper. The applicants have also examined the applicant no. 2 at Exh. 8. The applicant Aniket Dattatray Kove has deposed in line with the main application. Hence, I do not find any reason to reject the claim of applicants. Accordingly, I pass the following order:-

ORDER

1. The application is allowed.
2. Issue heirship certificate in the name of applicant namely, 1. Shital Dattatray Kove, 2. Aniket Dattatray Kove, 3. Ankita Dattatray Kove, 4. Priti Dattatray Kove, being legal heirs of deceased Dattatray Damaji Kove.
3. The writ or certificate be issued on payment of requisite stamp paper.
4. Case is closed.
