State v. Javed @Sonu @ Sulemani Bhaijan

Arguments heard on the point of charge.

Case of the prosecution is that on 11.09.2020 at 6.30 pm ASI Phool Kumar received secret information at the office of Narcotic Cell, Darya Ganj Delhi in respect of accused Javed resident of Jagapur, Wazirabad, that he will come to supply heroin to some one between 8.15 to 9 pm on the road along the *nullaha* opposite Jharoda Village. The secret information was reduced into writing vide DD No. 17A at 7.13 pm. Raiding party left for the disclosed spot at 7.34pm vide DD No. 18A and reached at the disclosed spot at about 8.15 pm. At around 8.45 pm one person wearing helmet on scooty no. DL 5S CF 5864 was seen coming from Burari side and going towards Sangam Vihar, who stopped some 20-30 meters from the vehicle of the raiding party, took out his helmet and started waiting for somebody and was identified by the secret informer by accused Javed and was apprehended by the raiding party. ACP Narcotic Cell Crime Branch was informed about the apprehension of

accused, who reached at the spot at 9.25 pm. Nothing was recovered in the personal search of the accused. The dicky of the scooty was checked and search of the scooty 500 grams of heroin was recovered.

From the material available on record, charge for an offence **under Section 21 (c) of NDPS Act** is made out against the accused.

Let charge be framed against the accused accordingly.
