**ORDERS ON IA.NO.III**

- 1.** I.A.No.III has been filed by the Applicant/ Decree Holder U/s. 151 CPC with the prayer to direct the Sub-Inspector of Police, Ajjampura Police Station, Ajjampura to give help to the Bailiff to execute the arrest warrant against Judgment Debtor No.2.
- 2.** In the affidavit appended to the application, it is contended that when Court Bailiff tried to execute the arrest warrant issued against Judgment Debtor No.2, the Judgment Debtor No.2 and his followers tried to manhandle the Court Bailiff and abused him in filthy language. The Judgment Debtor No.2 is politically influenced and powerful. If the application is not allowed, the Decree Holder will be put to great hardship. Hence, the prayer is to allow the application.
- 3.** Judgment Debtor No.2 has not filed any objections to the above application.
- 4.** Heard Learned Counsel for Decree Holder.
- 5.** Having heard and after perusal of materials placed on record, the sole point that would arise for my consideration is as under -

**“Whether the Applicant/ Decree Holder has made out sufficient grounds to allow the applications in I.A.No.III?”**

6. My answer to it is in the '**Affirmative**' for the following reasons -

7. The Court has already issued arrest warrant against Judgment Debtor No.2.

8. The Bailiff report shows that he has sought the assistance police for execution of the warrant. When such being the case, it is just and necessary to direct the police to provide assistance in order to protect peace tranquility in the society. If this application is rejected the whole purpose of getting the decree will be frustrated. With the aforesaid discussions, I answer the sole point which has arisen for my consideration in the '**Affirmative**' and proceed to pass the following -

**ORDER**

*I.A.No.III filed by the Applicant/ Decree Holder under Section 151 of C.P.C stands allowed.*

*The SHO of Ajjampura PS is hereby directed to render proper assistance to the Court Amen Bailiff the execution of warrant for arrest of Judgment Debtor No.2.*

*Re-issue A/W against the Judgment Debtor No.2, if P.F paid.*

*Issue intimation of this order to the SHO of Ajjampura PS.*
