STATEMENT OF THE ACCUSED U/S 313 of Cr.P.C.

Q.1 : Have you heard the evidence of the witness?

Q-2: PW-1 Praveena.R.V. has deposed in his evidence before the Court that you accused approached and borrowed hand loan of Rs.15,00,000/- from the complainant in the month of March 2021 for your family necessities, business urgent needs and also for legal necessities and after lapse of three months, you accused has issued three cheques bearing No.572301 dated 10.06.2021, cheque bearing No.572302 dated 12.06.2021 and cheque bearing No.572303 dated 20.06.2021 for a sum of Rs.5,00,000/- each drawn on Vijaya Bank (now Bank of Baroda) Rangenahalli branch. What do you say?

What do you say?
