I, B.S.Bharathi, Prl.District and Sessions Judge,
Chamarajanagar, do hereby charge you the accused:

Aged about 42 years,

Sategala-Jageri
Kollegal Taluk

as follows:

Firstly, that on 11.09.2018 at about 8.30 a.m, when the complainant police and his staff conducted raid in the land bearing Sy. No.174 situated at Jageri Shiluvaipura village of Sategala-Jageri, Kollegal Taluk, measuring 2 acres where you the accused was cultivating the land, along with CW-3, 4 panchas and CW-13 to 20 who are the staff of the complainant, they found you the accused had illegally cultivated about 10 cannabis/ganja plants in the said land in

between Jowar crop in the said land. without obtaining the license in contravening the provisions of NDPS Act, and thereby committed the offence punishable under Section 20(a)(i) of NDPS Act, 1985 within my cognizance.

Secondly, that on the aforesaid said date and place, when the complainant police and the above said staff CW-13 to 20 and panchas CW-3 and 4 conducted raid and on search of the said land, they found you the accused had possessed 10 cannabis plants weighing about 1 kilo 600 grams and value of same is Rs.1,500/- in the said land, the quantity involved is lesser than commercial quantity but greater than small quantity and thereby, you the accused have committed the offence punishable U/s.20(b)(ii)(B) of NDPS Act, 1985 within my cognizance

And I hereby direct that you be tried by this Court on the aforesaid charges.
