AWARD
UNDER SECTION 21 OF THE LSA ACT 1987 & AMENDEMENT ACT 1994

(A) The Respondent No 3 insurance company shall pay the petitioners a sum of Rs. 3,00,000/- (Three lakhs only) only As compensation for injury sustained towards full and final settlement of all claims arising out of the said accident.

(b) No interest or costs shall be payable to the petitioners

(c) The petition as against the respondent No 1 & 2 shall stand dismissed without costs in view of the settlement arrived at between the petitioner and respondent No 3

(d) An Amount of Rs. Nil Minor amount shall be invested in fixed deposits in any Nationalized for a period of one years, continue till they attain majority, after attaining majority minors are permitted to withdraw the entire amount as per award.

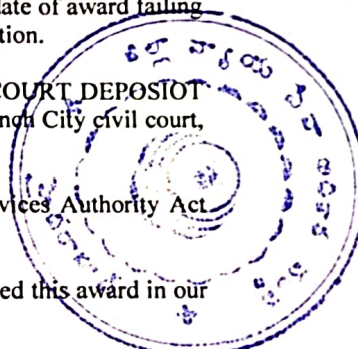
(e) the respondent No 3 shall deposit the compensation amount within one month from the date of award failing which 9% interest per annum will be calculated from the date of award till the date of realization.

(f) The respondent Company shall deposit the award amount directly in to the account COURT DEPOSIT SBI account No 00000039729738544 IFSC Code SBINoo20930Through RTGS/NEFT Branch City civil court, Hyderabad

(g) Petitioners is/are entitled for refund of court fee paid as per section 21 (1) Legal services Authority Act 1987.
