ORDER

The suit filed by the plaintiff seeking partition and separate possession is hereby decreed.

The Plaintiff deceased Siddanaika, Basamma and the defendant deceased Basavanaika and deceased Ninganaika children of Jogisidda are entitled for 1/4th share each in the suit schedule properties. The defendant are liable to pay separate Court fee with regard to their shares in the suit schedule properties.
