Order

1) The accused voluntarily pleaded guilty for the offence punishable under Sections 185 of Motor Vehicles Act, 1988. I verified and confirmed that the accused wants to plead guilty voluntarily. The plea is accepted.

2) Perused the record of the alleged incident. Heard the accused on the point of sentence. He prayed for leniency on the ground that his financial condition is poor. Taking into consideration the plea, the accused deserves leniency. With this observation, I pass the following order.

ORDER

- (i) The accused Rishiraj M. Tandel is convicted for the offences punishable under Sections 185 of M.V. Act vide section 252 of the Code of Criminal Procedure and is sentenced to pay the fine of Rs. 10,000/- (Rupees Ten Thousand Only) I/d to undergo S.I. for 07 days.
- (ii) The Superintendent is directed to hand over the original driving licence/RC book to the accused, after payment of fine.
