ORDER:-

Today, an application has been filed by counsel for the applicant / accused for amendment of head note of bail application for adding Section 238 of BNS in the bail application. Counsel for the applicant /accused has submitted that during the investigation, the investigating agency has recently added Section 238 of BNS in the present case and prayed that Section 238 of BNS be added in the head note of the bail application. In the interest of justice, in the instant application is allowed and Reader is directed to make necessary addition in the head note of the bail application.

2. The instant bail application under Section 482 of BNSS has been filed on behalf of applicant/accused in the above noted FIR.

3. Upon notice, Additional Public Prosecutor appeared on behalf of State and record was summoned.

4. I have heard the learned counsel for the applicant/accused and the learned Addl. PP for the State.

5. Applicant/accused Beant Singh was admitted to interim bail vide order dated 15.7.2026 passed by this court, subject to condition that applicant/accused shall join the investigation and cooperate with the same.

6. Today, ASI Kabal Singh no.135/Ldh, (R) P.S Jodhan, Ludhiana suffered a statement in writing that accused Beant Singh has joined the investigation and his custodial interrogation is not required.

7. So keeping in view the facts and circumstances of the case order dated 15.7.2026 passed by this court vide which accused/applicant Beant Singh was admitted on interim bail is made absolute and stands confirmed. Thus, bail application is allowed. Applicant/ accused Beant Singh shall also comply with the following provision of Section 482 (2) BNSS,2023 :-

1. That the applicant/ accused will not directly or indirectly make any inducement, threat or promise to any person acquainted with the facts of case so as to dissuade him from disclosing such facts to the court or to any police officer.

2. That the applicant/ accused will not leave the territory of India without prior permission of the court.

3. That the applicant/accused will continue to cooperate with the investigation and shall also join the investigation as and when required/directed by the Investigating Officer.
