The State has moved an application in the Request Form for Video Conference in terms of Schedule II of the Video Conferencing Rules of the High Court of Delhi (VC Rules) for examining witness Puneet Gupta through VC.

Since the witness has expressed willingness for deposition through VC and it would be expedient to record the deposition through VC on account of the previous adjournments for examination of this witness, the application is allowed.

Upon the joint submission of the respective counsels and the witness, Ms. Vineeta, Ld. Counsel for the witness is appointed as the coordinator at the remote point (place of deposition of Mr Puneet Gupta) in terms of Rule 5.3.8 of the VC Rules. The remote point shall be the chamber/office of counsel Ms. Vineeta. The coordinator shall ensure compliance with Rule 5.6 of the VC Rules.

Witness Mr. Puneet Gupta shall furnish proof of identity in terms of Rule 8.1 of the VC Rules prior to the next date of hearing.

The prosecution is directed to ensure that a copy of the document, if any, sought to be relied upon by the witness/prosecution is transmitted to witness Mr. Puneet Gupta in order that he may acquire familiarity with the said document. The prosecution shall file an acknowledgment with the court in this behalf.

The Ahlmad of the court shall ensure that the summons to the witness are accompanied by a certified photocopy of the document, if any.

Let a copy of this order be sent to Coordinator - Ms. Vineeta and witness - Mr. Puneet Gupta. A copy of the order be also provided to the prosecution.
