ORDER ON MAIN PETITION

This petition filed by the petitioners under Section 13(3) of the Registration of Births and Deaths Act, Seeking directing to the respondent to enter the date of death of **Ankashetty S/o Late Jogimadana Siddashetty**, in the death Register maintained by the respondent.

2. Notice was issued to respondent. In spite of service of said notice, respondent remained absent. Hence, respondent placed Exparte.

3. Heard. Perused the materials on record.

4. The Petitioner No. 2, to prove the contents of the petition, got examined himself as P.W.1 and he has reiterated the contents of the petition averments in her examination-in-chief and to prove his case, also relied upon Exs.P-1 to 8 documents.

5. It is the contention of the petitioner that, deceased **Ankashetty S/o Late Jogimadana Siddashetty** is the Father-in-law of the petitioner No.1, Grand-father of the petitioner No. 2 and 3, Father of the petitioner No.4. The said **Ankashetty S/o Late Jogimadana Siddashetty was died on 22.02.1998 in the residence of petitioners at Honnuru Village, Yelandur Taluk Chamarajanagar District.** The petitioner no.2 was under the impression that the other family members might have given the intimation of the death event of his Grand-father to the respondent office. When the petitioner no.2 approached to obtain the death certificate of his Grand-father, the respondent issued endorsement. The petitioner no.2 proves that, he has

approached the respondent and has produced Ex.P-1 Non-availability certificate issued by the respondent. Further PW-1 has produced genealogical certificate as per Ex.P-2, true copy of Aadhar cards of Petitioner No.1 to 4 as per Ex.P-3 to Ex.P-6. The PW-1 has also taken the public notice as per the direction of this Court in 2 news papers which are produced as per Ex.P-7 and Ex.P-8. These Ex.P-1 to 8 support the contention of petitioners. Hence, I am of the opinion that, there are no grounds to reject the petition. Further, in the event of allowing the petition, no other persons will be put into loss or injustice. On the other hand, in the event of rejecting the petition, the petitioner will be put into great hardship and injustice. Under the circumstances, the petition is liable to be allowed. Hence, I proceed to pass the following:-
