ORDER ON MAIN PETITION

This petition filed by the petitioner under Section 13(3) of the Registration of Births and Deaths Act, Seeking directing to the respondent to

enter the date of death of **Puttalingamma W/o Late Shivappa** in the death Register maintained by the respondent.

2. Notice was issued to respondent. In spite of service of said notice, respondent remained absent. Hence, respondent placed Exparte.

3. Heard. Perused the materials on record.

4. The Petitioner to prove the contents of the petition, got examined himself as P.W.1 and he has reiterated the contents of the petition averments in his examination-in-chief and to prove his case, also relied upon Ex.P-1 to 6 documents.

5. It is the contention of the petitioner that, deceased **Puttalingamma W/o Late Shivappa** is the aunt of the petitioner. The said **Puttalingamma W/o Late Shivappa who was died on 11.03.1974 in the residence of petitioner at Kesthur Village, Agara Hobli, Yelandur Taluk, Chamarajanagar District.** The petitioner was under the impression that the other family members might have given the intimation of the death event of his aunt to the respondent office. When the petitioner approached to obtain the death certificate of his aunt, the respondent issued endorsement. The petitioner proves that, he has approached the respondent and has produced Ex.P-1 Non-availability certificate issued by the respondent. Further PW-1 has produced the true copy of genealogical certificate as per Ex.P-2, true copy of Aadhar card of Petitioner as per Ex.P-3, true copy of Ration card of Petitioner as per Ex.P-4. The PW-1 has also taken the public notice as per the direction of this Court in 2 news papers which are produced as per Ex.P-5 and 6. These Ex.P-1 to 6 support the contention of petitioner. Hence, I am of the opinion that, there are no grounds to reject the petition. Further, in the event of allowing the petition, no other persons will be put into loss or injustice. On the

other hand, in the event of rejecting the petition, the petitioner will be put into great hardship and injustice. Under the circumstances, the petition is liable to be allowed. Hence, I proceed to pass the following:-

The petition filed by the petitioner under Section 13(3) of the Registration of Births and Deaths Act, 1969, is hereby allowed.

The respondent is hereby directed to enter the date of death of **Puttalingamma W/o Late Shivappa who was died on 11.03.1974 in the residence of petitioner at Kesthur Village, Agara Hobli, Yelandur Taluk, Chamarajanagar District**, in the concerned Death register, after deposit of required fee if any and issue extract to that effect in favour of the petitioner.
