-::CHARGE::-

I, Akarsh M. BA. LLM., Judicial Magistrate First Class,
Yelandur, do hereby charge you accused:

- 1) Mallanayaka,
S/o Puttamadanayaka,
Age: 43 years,
- 2) Gowramma,
W/o late Y.S Rangaraju,
Age: 41 years,
- 3) Manjula,
D/o late Y.S Rangaraju,
Age: 20 years,

A1 to 3 are R/o: 5th Ward, Yalekere Street,
Yelandur Town, Chamarajanagara Dist.

- 4) Abhishek @ Abhi S/o Basavanna,
Age: 24 years,

- 5) Basavanna @ Hotel Basavanna,
S/o Hanumanthanayaka,
Age: 49 years,

A4 & 5 are R/o: 6th Ward, Yalekere Street,
Yelandur Town, Chamarajanagara Dist.
- 6) Manju,
S/o Puttamadanayaka,
Age: 46 years,
R/o: 5th Ward, Yalekere Street,
Yelandur Town, Chamarajanagara Dist.

As hereunder:-

That on 25.11.2021 at about 08.30 P.M. within the limits of Kuderu Police Station at Yelandur village, you accused Nos.1 to 6 in prosecution of common object of committing offences against CW1 (Mallajamma), CW2 (Janakamma) to CW3 (Sridevi), CW5(Punithraj) & CW6 (Mahesh), you have formed yourselves into an unlawful assembly and thereby accused Nos.1 to 6 have committed an offence punishable U/sec.143 of IPC and is within the cognizance of this Court.

Secondly, on the above said date, time & place you accused Nos.1 to 6 in prosecution of common object of the aforesaid assembly, the violence has been used against the CW1 to 3, 5 & 6, as such you accused Nos.1 to 6 have committed an offence of rioting which is made punishable U/sec.147 of IPC and is within the cognizance of this Court.

Thirdly, on the above said date, time & place you accused Nos.1 to 6 in prosecution of common object of committing offences against CW1 to 3, 5 & 6, you accused No.3 has trespassed the house of CW4 (Gowramma), as such you accused Nos.1 to 6 have committed an offence of house-trespass which is made P/U/Sec.448 R/w 149 of IPC and is within the cognizance of this Court.

Fourthly, on the above said date, time & place you accused Nos.1 to 6 in prosecution of common object of committing offences against CW1 to 3, 5 & 6, you accused No.1 has beaten CW2 by hands on her backside, you accused Nos.2 & 3 have beaten CW3 by hands on hands and body, when CW5 came to pacify the quarrel you accused Nos.4 & 5 have pulled the shirt and beaten CW5 by hands on his shoulder, as such you accused Nos.1 to 6 have committed an offence of voluntarily causing hurt which is made punishable U/sec.323 R/w 149 of IPC and is within the cognizance of this Court.

Fifthly, on the above said date, time & place, you accused Nos.1 to 6 in furtherance of the aforesaid common intention of committing offences against CW1 to 3, 5 & 6, you accused No.3 has pulled the hair of CW1 and pushed outside the house, you accused Nos.1, 3 to 6 have pulled the hair of CW2, as such you accused Nos.1 to 6 have committed an offence of assault or criminal force to woman with intent to outrage her modesty which is made P/U/Sec.354 R/w 34 of IPC and is within the cognizance of this Court.

Lastly, on the above said date, time & place you accused Nos.1 to 6 in prosecution of common object of committing offences against CW1 to 3, 5 & 6, you accused No.6 has used filthy languages against CW6 as “ಎ ಬೋಳಿಮಗನೇ ಇಲ್ಲಿ ನಿನಗೆ ಏನು ಕೆಲಸ”, with an intention to provoke them to breach the public peace, as such you accused Nos.1 to 6 have committed an offence of intentional insult with an intent to provoke to commit the breach of public peace which is made punishable U/sec.504 R/w 149 of IPC and is within the cognizance of this Court.
