2.	Applicants/accused be released on bail on furnishing P.R. and S.B. of Rs.25,000/- each (Rs. Twenty Five Thousand) with one surety in the like amount.
3.	Applicants/accused shall attend the concerned police station on fourth Wednesday of the month in between 11.00 a.m to 2.00 p.m till disposal of main application.
4.	Issue notice to respondent and informant returnable on 15.02.2023.
5.	Inform to concerned Police Station accordingly.
