**C H A R G E**

I, VELA D K., B.A., LL.B., (Hons), M.A (Crl.Law & Forensic Science) Principal District and Sessions Judge, Davanagere do hereby charge you;

4. *Naga @ Ningaraja Ispeet Venkatesha, Age: 23 years, Occ: Coolie, R/o Betur road, Koracharahatti, Davanagere. – (Split up from SC.No.9/2016.)*

as follows;

1. That on 22-9-2013 at about 8-450 PM in the compound place of Renuka Mandira, Davanagere, while CW-1 along with CW-8 to 16 came out after completion of farewell function National Power Lifting competition held at Renuka Mandira, Davanagere, you accused No.4 along with other accused in SC.9/2016 being the members, formed an unlawful assembly with the common object of committing murder of CW-1 Srinivas S/o Late Nagappa as he was the cause for murder of deceased Hemanth and thereby you have committed an offence punishable u/s. 143 R/W 149 of IPC and within my cognizance.

2. That on the above said date, time and place you accused No.4 along with other accused in SC.9/2016 being the members, formed an unlawful assembly with the common object and in prosecution of common object of such assembly committed rioting against the CW-1 and CW-8 to CW-16 and thereby you have committed an offence punishable u/s.147 R/W 149 of IPC and within my cognizance.

3. That on the above said date, time and place you accused No.4 along with other accused in SC.9/2016 being the members, formed an unlawful assembly with the common object and in prosecution of common object of such assembly committed rioting armed with machete and **ಶೂರ್ಪ** which are the lethal weapons used to assault CW-1 Srinivas and thereby you have committed an offence punishable u/s. 148 R/W 149 of IPC and within my cognizance.

4. That on the above said date time and place you accused No.4 along with other accused in SC.9/2016 being the members, formed an unlawful assembly with the common object intentionally insulted the CW-1 and CW-8 to 16 by abusing them in filthy language and thereby gave provocation to them, intending that such provocation would cause them to break the public peace, and thereby you committed an offence punishable under Sec. 504 r/w Sec. 149 of I.P.C. and within my cognizance.

5. That, on the above said date, time and place, you accused No.4 along with other accused in SC.9/2016 being the members, formed an unlawful assembly with the common object of committing murder of CW-1 Srinivas, who after he came out

from attending the farewell function of National Power Lifting Competition, held at Renuka Mandira, Davanagere, you accused No.1 and 2 holding the machete and longu in their hands and throw the said lethal weapons on CW-1 Srinivas to commit his murder and CW-1 was escaped from the said assault instead CW-8 and CW-9 sustained bleeding injuries and you attempted to commit murder of CW-1 Srinivas, if by that act you had caused death of CW-1 Srinivas, you accused would have been guilty of commit murder of CW-1 Srinivas and thereby you accused have committed an offence punishable under Sec. 307 r/w Sec. 149 of I.P.C and within my cognizance.

And, I do hereby direct that you be tried by this Court on the above said Charges.
