

That you accused being a public servant while working as Village Accountant in Belalagere Circle, Channagiri Taluk, on 24/09/2017, had given a missed called through your mobile phone bearing No. **9483930883** to the mobile number of C.W. 1 R. Venkatesh bearing No. **7975806191** and then C.W. 1 called you to your above referred mobile number, at that time, you accused through mobile phone demanded an amount of Rs.80,000/- as illegal gratification as a motive or reward from the complainant Sri. R. Venkatesh, to show an official favour i.e., for Change of Khatha in respect of Sy. No. 227/1 measuring 1 acre situated at Belalagere Village, as C.W. 1 purchased the said land and registered the same in their name on 23/06/2017 stating that “

Thereafter on 25/09/2017, C.W. 1 met you accused in the Nada Kacheri of Basavapattana and talked with the above said matter as stated above and then you accused demanded an amount of Rs. 50,000/- as final settlement from the C.W. 1-, and on 27/09/2017, near Receptionist's Counter at Dwaraka Hotel which is situated opposite to Old Bus Stand, Davanagere, you accepted the above said amount of Rs.40,000/- out of Rs. 50,000/- as illegal gratification as a motive or reward from C.W.1, to show above said official favour and thereby committed an offence punishable under Section 7 of Prevention of Corruption Act 1988 and within my cognizance.

That you accused being public servant while working as Village Accountant, Belalagee Village of Channagiri Taluk near Receptionist's Counter at Dwaraka Hotel which is situated opposite to Old Bus Stand in Davanagere City, at about 3.45 PM obtained a sum of Rs. 40,000/- by corrupt or illegal means from C.W.1 to show an official favour i.e., for change of Khatha in respect of Sy. No. 227/1 measuring 1 acre situated at Belalagere Village in the name of C.W. 1, and has committed mis-conduct in the discharge of your Official duty, thereby committed an offence punishable under Section 13(1)(d) read with Section 13(2) of Prevention of Corruption Act 1988 and within my cognizance.

And I hereby direct that you be tried on the said charge.
