Order below Exh.No. 01Civil Miscellaneous Application No. 41/2026Santosh & Ors. Vs. Nil(Passed on 6th August, 2026)

1. The present application has been filed by the applicants seeking Succession Certificate under Section 372 of the Indian Succession Act, 1925.
2. According to the applicants, Sudam Tukaram Bhosle died on 19.09.2025 at Suhagan, Tq. Purna, Dist. Parbhani. The permanent residence of the deceased at the time of death was at Shrikrushna Nagar, Parbhani. Applicant No.1 & 2 are sons, applicant Nos. 3 & 4 are daughter and applicant No.5 is wife of deceased. The applicants are only Legal heirs of the deceased and except them, there is no other legal heir or successor to deceased.
3. It is further case of the applicants that, during lifetime, the deceased was having some deposits which are standing by his name in the various bank accounts. The details of which is shown as under :-

4. The applicants approached to the above cited banks for withdrawing the amount standing in the name of the deceased. However, they were directed by the respective bank authorities to obtain the succession certificate. Accordingly, the present application came to be filed.

5. On this application, this Court directed citation and public notice calling objections. However, no one stepped ahead to object this application till the date.

6. At Exh.No.11, applicant No.2 Balaji Sudamrao Bhosle testified himself to prove the claim of the applicants. The applicants relied upon the verified copy of the death certificate of deceased Sudam at Exh.12, verified copies of bank passbook extract at Exh.Nos.13 to 16 respectively, verified copy of aadhaar card of deceased, verified copy of PAN card of deceased at Exh.No.18, verified copies of aadhaar card of applicants at Exh.Nos.19 to 23 respectively. They further relied upon citation &

public notice vide Exh.Nos.7 & 8, and issue of newspaper at Exh.No.24.

7. Heard learned Advocate for the applicants. He submitted according to the contents of the application. Considered the record before the Court.

8. Having regard to entire facts and circumstances, it appears that, death place of deceased is at Suhagan, Tq. Purna, but considering his permanent residence at Shrikrushna Nagar, Parbhani, and also considering the total amount of Rs. 5,48,034/- for which succession certificate is claimed, this Court is vesting jurisdiction to decide this application. Moreover, perusal of bank statements shows respective amount is standing by the name of deceased in the concerned banks. Despite citation and public notice, no one stepped ahead or raised any objection about the claim of the applicants. The applicants are appearing to be the only successors of the deceased. The applicants led sufficient oral and documentary evidence to prove their claim. There is no impediment to consider this application. Hence, I pass the following order :-

ORDER

- (i) The application stands allowed.
- (ii) On depositing the proper Court fees, issue Succession Certificate in favour of applicant Nos.1 to 5

for withdrawing the amount with interest accrued thereon, if any, from the concerned bank standing in the name of deceased **Sudam Tukaram Bhosle** as detailed below :-
