ORDERS ON BAIL PETITION

Accused No.2 to 7 has filed bail application U/sec 437 of Cr.P.C. to enlarge them on bail in connection with the offence punishable 380, 411 of IPC.

It is contended in the bail application that, the accused No. 2 to 7 are innocent for the offences leveled against them and They are not committed any such alleged offences. Accused No.2 to 7 is permanent resident of Khalaghatta Village and they have law abiding persons. Their family situated there at. The accused No.2 to 7 are earning member to their family. They are also ready to furnish adequate surety and also they are ready to undertake to appear before the court without fail.

The learned APP filed objections along with objections to bail application and prays to reject the same.

Heard the arguments and perused the materials available on record.

Admittedly, the case is registered against the accused No. 2 to 7 for the offense punishable U/Sec. 380 , 411 of IPC and the same is non bailable, but the same is not punishable with death or imprisonment for life. Further the alleged offences are exclusively triable by this court. The accused persons ready to ensure their presence by providing surety. Hence by imposing certain conditions the presence of the accused No. 2 to 7 can be secured before this court and there by the apprehension of the prosecution that accused may abscond from the jurisdiction of this court is also be safeguarded. Hence, I proceed to pass the following :

ORDER

The bail application filed by the Accused No.2 to 7 U/Sec. 437 of Cr.P.C., is here by allowed and accused No.2 to 7 and on bond for Rs.50,000/- each with

one local surety for like sum, subject to following.

CONDITIONS

1. Accused No.2 to 7 shall not commit the similar kind of offence.
- 2.They shall not tamper the prosecution evidence and shall not threaten the prosecution witness.
3. They shall appear before the court regularly.

The accused No.2 to 7 shall submit their recent ID proof.
