ORDERS ON BAIL PETITION

Accused No.2 to 4 have filed bail
application U/sec 437 of Cr.P.C. to enlarge
them on bail in connection with the
offence punishable U/S 323,324,504,506
R/w 149 of IPC.

It is contended in the bail
application that, the accused persons are
innocent for the offence leveled against
them and they have not committed any
such alleged offence. Accused persons
permanent resident of Channagiri Taluk,
Davangaere district and they are law
abiding persons. Having families and are
depending on their earnings.

The learned APP filed objection and
prays to reject the same.

Heard the arguments and perused
the materials available on record.

Admittedly, the case is registered
against the accused persons for the offense

punishable U/S 323,324,504,506 R/w 149 of IPC. out of the same the section 1 323,324,504,506 R/w 149 of IPC are non bailable, but the same is not punishable with death or imprisonment for life. Further the alleged offence is triable by this court. The accused persons are ready to ensure their presence by providing surety. Hence by imposing certain conditions the presence of the accused persons can be secured before this court and there by the apprehension of the prosecution that accused may abscond from the jurisdiction of this court is also be safeguarded. Hence, I proceed to pass the following :

ORDER

The bail application filed by the Accused No. 2 to 4. U/Sec. 437 of Cr.P.C., is here by allowed and accused on bond for Rs.50,000/- each with one local surety for like sum, subject to following.

CONDITIONS

1. Accused No.2 to 4 shall not commit the similar kind of offence.

2. They shall not tamper the prosecution evidence and shall not threaten the prosecution witness.

3. They shall appear before the court on each hearing date without fail

The accused No.2 to 4 shall submit their Adhar Card copies.
