SUIT CLAIM ::

Plaint Under Order 7 Rule 1 of CPC on behalf of the plaintiff prays that the Hon'ble court may be pleased to pass a judgment and decree in favour of plaintiff bank against the defendant for the recovery of sum of Rs.1,74,760-00 together future interest at the rate of 12 % p.a., with panel interest 2% from the date of the suit till the realization of the entire amount and court costs and current and future interest and such other reliefs as this Hon'ble Court deems fit to grant under the circumstances of the suit in the ends of justice and equity.

This suit is coming on this 15th day of July 2026 for final disposal before **Shri. Vajresha**, B.A, LL.B., II Addl. Civil Judge & J.M.F.C., Channagiri, and in the presence of Shri. S. Prasanna Kumar , advocate for the plaintiff and defendant placed exparte.

By Judgment, it is ordered and decreed that, the suit filed by the plaintiff bank is hereby decreed with cost.

It is further ordered and decreed that, the plaintiff bank is entitled to recover the suit claim amount of Rs.1,74,760/- from the defendant with further interest at the rate of 12% p.a from the date of the suit to the date of decree and future interest at the rate of 6% p.a. on principal amount from the date of decree till realization.

It is further ordered and decreed that, the defendant is liable to pay the decretal amount within 3 months from the date of this order. On failure to comply the same, the plaintiff bank is at liberty to recover the same through the due process of law.

It is further ordered and decreed that, interlocutory applications pending, if any, do not survive for consideration in view of the main suit being decreed.

It is further ordered and decreed that, the defendant is liable to pay cost of Rs.17,117-00 to the plaintiff bank.
