Notices issued to MHC(M), IO/ASI Soran Singh and witness Naseem are received back with reports 'served'.

Today, on calling the case, only MHC(M) Ct. Raj Kumar has appeared with case property.

IO/ASI Soran Singh has sent request that he is busy in the investigation of some other case, so, he could not appear in the court. So, he is granted exemption from personal appearance for today.

Since, witness Naseem did not appear, despite service till 11:30 AM and since, accused, who is in JC, has also not been produced till 11:30 AM. So, the matter stands passed over till 11:40 AM for appearance of the witness Naseem and production of the accused from JC.

Since, the regular Addl. PP posted in this court has already been promoted and transferred and the Addl. PP for the State, who has been transferred to this court has not come today.

Ld. substituted Addl. PP for the State has come in this court at 10:30 AM and left this court at 11:30 AM, after making request that he has to examine the witnesses in his POCSO Court.

The matter was passed over for 11:40 AM, for awaiting the witness Naseem and for production of the accused from JC. But, at that time, Ld. Substituted Addl. PP for the State was busy in his regular court and Ld. Substituted Addl. PP has come again at 12:40 PM, so, the matter is taken up at 12:40 PM for recording evidence of the witness Naseem.

Sh. Parveen Yadav, Ld. Legal Aid Counsel for the accused has submitted that he may be discharged. So, he is discharged in the present case.
