CLAIM

This petition is filed by the Petitioner U/Sec.22 of the Workmen Compensation Act 2000 on 02-09-2023 and prays to pass an award of compensation to the Petitioner as per schedule of the alongwith medical bills, interest on award amount at the rate of 18% p.a. and such other reliefs as the Hon'ble court thinks deems fit under circumstances of the case, in the interest of justice.

This case is coming on this day for final disposal before me in the presence of Sri.M.Nagendrappa Advocate for Petitioner, Sri.N. Parashuramappa, Advocate for Respondent No. 1 and 2.

BY JUDGMENT.

The petition filed by the Petitioner U/Sec.22 of the Employees compensation Act, 1923 is allowed in part with cost.

It is further ordered and decreed that the Petitioner is entitled for Rs.1,38,083/- (Rupees one Lakhs Thirty Eight Thousand and Eighty Three only) with interest at the rate of 12% p.a.from the accident i.e., from 09.02.2023 till realization.

It is further ordered and decreed that , Respondents No.1 and 2 are jointly and severally liable to pay compensation amount.

It is further ordered and decreed that , Respondents No.1 and 2 directed to deposit award amount within two months from the date of award.

It is further ordered and decreed that on deposit of the award amount, entire compensation amount is ordered to be released in favour of the Petitioner by creating a recipient I.D. in Khajan-2 after due verification and on the Petitioner furnishing necessary documents about the bank particulars and his identity.

It is further ordered and decreed that Advocate's fees is fixed at Rs.500/-.
