By Judgement, it is ordered and decreed that the suit of the plaintiffs is hereby decreed with costs.

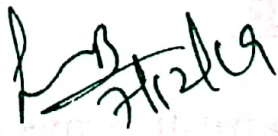

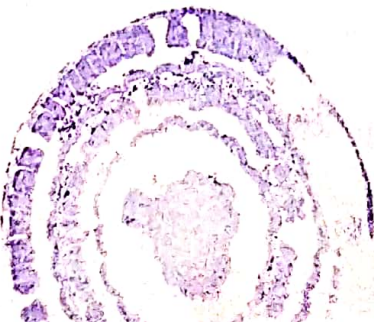
The defendant do pay a sum of Rs. 1053/- to the plaintiff towards the cost of the suit.

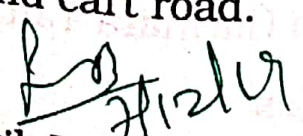
