Examination in Chief: by Learned APP:

Since from 6 years I am serving as Gynecologist, Government Hospital, Harihar.

On 10.02.2021 at about 10.50 PM the one by name Indira, aged 34 years approached me with a history of assault. On examination I have found the following injuries

“ Lower leaf was swolled, One tooth was fallen down and another tooth was loosen and was intact pleat”.

In my opinion the above mentioned injury was grievous in nature. It is true to suggest that the above mentioned injury may caused by a person by hitting with his elbow. Accordingly I have issued wound certificate. Now I am seeing said wound certificate and it bears my signature. It is true to suggest that the injury mentioned in the Ex.P.8 may cause to a person when the fallen down on road. It is also true to suggest that the injury mentioned in the Ex.P.8 may

cause to a person when he/she has hit by some hard object. It is false to suggest that I have issued false wound certificate of CW.1. It is false to suggest that in order to help the CW.1, I am deposing falsely.
