PRAYER:- Plaintiff most humbly pray for judgment and decree in its favour against the defendants, by directing the defendants to pay the sum of Rs. 1,21,679=00 (Rupees One lakh twenty one thousand six hundred Seventy Nine only) with agreed rate of interest at Rs.13.50% P.A. compounded half yearly from the date of suit till payment with court costs, and to grant such other reliefs which are deem fit to grant under the circumstances of the case in the interest of justice and equity.

This suit is coming on 10th day of June-2026 for final disposal before Smt. Chetana Arikatti, B.A. LL.B.(Hons),LL.M., II Addl. Civil Judge & JMFC, Harihar, in the presence of Sri. B.Halappa, Advocate for Plaintiff. Defendants No.1 to 6 are Placed Exparte.

By judgment it is ordered and decreed that the suit of the plaintiff bank is partly decreed with costs.

Further it is ordered and decreed that the defendants are jointly and severally liable to pay Rs.1,21,679/-(Rupees One Lakh twenty one thousand six hundred seventy nine only) to the plaintiff bank the suit claim amount together with interest at 6% per annum from the date of suit till realization within 6 months from the date of this judgment.

Further it is ordered and decreed that the claim of the plaintiff for compound interest at the rate of 13.50% p.a. from the date of suit till realization is rejected.

The Defendants do pay a sum of Rs. 8,175/- to the plaintiff bank towards cost of the suit.
