PRAYER:- The Plaintiff most humbly pray for judgment and decree in its favour against the defendants, by directing the defendants to pay the sum of Rs.1,66,193=00 (Rupees One Lakh sixty six thousand one hundred Ninty three only) with agreed rate of interest at Rs.14% P.A. compounded half yearly from the date of suit till payment with court costs, and to grant such other reliefs which are deem fit to grant under the circumstances of the case in the interest of justice and equity.

This suit is coming on 13th day of JULY-2026 for final disposal before Sri. Shrinivas Patil, B.A. LL.B.,LL.M., I Addl. Civil Judge & JMFC, Harihar, in the presence of Sri. B.Halappa, Advocate for Plaintiff. Defendants No.1 and 2 are Placed Exparte.

By judgment it is ordered and decreed that the suit of the plaintiff bank is hereby partly decreed with cost.

Further it is ordered and decreed that it is held that defendant No.1 and 2 are jointly severally liable to pay an amount of Rs.1,66,193/- together with court costs, with current and future interest at the rate of 6% p.a. from the date of the suit till its realization.

The defendants are directed to pay the amount ordered above within three months from the date of this order.

The Defendants do pay a sum of Rs. 13,833/- to the plaintiff bank towards cost of the suit.
