PRAYER:- The Plaintiff most humbly pray for judgment and decree in its favour against the defendants, by directing the defendants to pay the sum of Rs.2,19,264=00 (Rupees Two Lakhs Ninteen thousand Two hundred Sixty four only) with agreed rate of interest at Rs.11.00% P.A. compounded half yearly from the date of suit till payment with court costs, and to grant such other reliefs which are deem fit to grant under the circumstances of the case in the interest of justice and equity.

This suit is coming on 16th day of JULY-2026 for final disposal before Sri. Shrinivas Patil, B.A. LL.B.,LL.M., I Addl. Civil Judge & JMFC, Harihar, in the presence of Sri.Arunkumar B. Advocate for Plaintiff. Defendants No.1 to 6 are Placed Exparte.

By judgment it is ordered and decreed that the suit of the plaintiff is hereby partly decreed with costs.

Further it is ordered and decreed that the plaintiff bank is entitled to recover Rs.2,19,264/- together with simple interest at the rate of 6% p.a. from the date of suit until realization from the estate of deceased Basavanagouda, which has come into the hands of defendant No.1 to 6 within 6 months.

The Defendants do pay a sum of Rs. 17,959/- to the plaintiff bank towards cost of the suit.
