PRAYER:- Pray for judgment and decree in its against the defendant, by directing the defendant to pay the sum of Rs.1,36,638=00 (Rupees one lakh thirty six thousand six hundred thirty eight only) with interest at Rs. 11.70% from the date of suit till payment as agreed upon with court costs, and to grant such other reliefs which are deem fit to grant under the circumstances of the case in the interest of justice and equity.

This suit is coming on 7th day of August-2026 for final disposal before Sri. Birappa Kamble, B.A.,LL.B.(Hons), C/C. II Addl. Civil Judge & JMFC, Harihar, in the presence of Sri. B. Anand Kumar , Advocate for the Plaintiff. Defendant is placed Exparte.

Further it is ordered and decreed that, the defendant is jointly and severally liable to pay to the plaintiff-bank Rs. 1,36,638-00 with future interest at the rate of 11.70% per annum from the date of decree to till its realization.

And it is further ordered and decreed that the defendant fail to repay the same, the plaintiff-bank is entitled to recover the above amount in accordance with law.

The Defendant do pay a sum of Rs. 11,536-00 to the plaintiff towards the cost of the suit.
