This petition came up before me today in the presence of Tr.Raja.Selvakumar, Advocate for the petitioner / Accused and of Thiru.V.Thanigaiselvam, Special Public Prosecutor for the Respondent/Complainant and upon hearing both sides and upon perusing the records, today this court passed the following:

ORDER

The petitioners have been granted bail for the alleged offences U/s.296(b), 115(2), 351(2) and 108 of BNS and 3(1)(r), 3(1)(s) of SC/ST (PoA) Act in Cr.No.27/2026, vide order of this Court in CrI.M.P. No.93/2026, Dated 23.06.2026, with condition that the petitioners shall appear and sign before the SHO, Kammapuram Police Station daily at 10.30 a.m., until further orders.

2. The petitioners have filed this petition seeking to relax the condition imposed on them.

3. The learned counsel for the petitioners submitted that the petitioners have been complying the condition from 24.06.2026 to till date without fail and the petitioners are only bread winner of their family and they are struggling to abide condition and prays to relax the condition imposed on them.

4. The learned Special Public Prosecutor submit that the petitioners are complying the condition from without fail and if the condition is relaxed on the petitioners, they will hamper the witnesses and they will not appear before this Court for hearings. Hence, the Special public prosecutor objected to relax the condition.

5. Reply received. Heard. Considering regular compliance and investigation is completed and the case was taken on file as S.C.No.33/2026, condition totally relaxed for the petitioner to appear before the court on all hearing dates, till disposal of the case.

In the result, this petition is allowed and the condition is totally relaxed and the petitioners shall appear on all hearing dates before this Court till disposal of the case. Other conditions remain un-altered.
