JUDGMENT**(Date 01/08/2026)**

The accused is charge-sheeted for the offences punishable under section 279, 427 of IPC and under section 139 of Electricity Act.

2. The charges Exh.9 of the accused read over and explained to the accused. The accused has submitted an application below Exh.7 and he pleaded guilty voluntarily for the offence punishable under Section 279, 427 of the Indian Penal Code and Section 139 of Electricity Act, 2003. The accused has prayed for the leniency. On the other side Ld. A.P.P. Shri. S. R. Hingmire has submitted maximum sentence be imposed.

3. Considering the nature of the offence and submission of the Ld. Advocate of the accused Shri. S. H. Pathan and Ld. A.P.P. Shri. S. R. Hingmire, the accused is held guilty under section 279, 427 of I.P.C. and 139 of Electricity Act. It is necessary to pass leniency sentence. In the result, I pass the following order.

ORDER

- [1] The accused Jamil Ahamad Patrusab Mulla is hereby convicted as per section 229 of Criminal Procedure Code for the offence punishable under Section 279 of the Indian Penal Code and is sentenced to pay fine of Rs.1000/- (Rs. One Thousand only) in default to suffer S.I. For 6 days.
- [2] The accused Jamil Ahamad Patrusab Mulla is hereby convicted as per section 229 of Criminal Procedure Code for the offence punishable under Section 427 of the Indian Penal Code and is sentenced to pay fine of Rs.5000/- (Rs. Five Thousand only) in default to suffer S.I. For 12 days.
- [3] The accused Jamil Ahamad Patrusab Mulla is hereby convicted as per section 229 of Criminal Procedure Code for the offence punishable under Section 139 of Electricity Act, 2003 and is sentenced to pay fine of Rs.10,000/- (Rs. Ten Thousand only) in default to suffer S.I. For 24 days.
- [4] All sentences shall be run concurrently.
- [5] He is entitled to set off as per section 428 of Criminal Procedure Code.
- [6] Issue conviction warrant against accused accordingly.
- [7] True copy of this order be given to accused 'free of costs.'
- [8] It is informed to accused he has right to prefer appeal.
