PRAYER

WHEREFORE, the Plaintiffs pray for judgment and decree in their favor against the defendants for the following reliefs:

- (a) Declare that the Plaintiffs are having legitimate 1/4th share in the plaint schedule property;
- (b) direct the defendant No.3 to 7 to partition the plaint schedule property by metes and bounds and to deliver the 1/4th legitimate share on their failure, the Hon'ble Court be pleased to partition the property by metes and bounds by referring the matter to the

Deputy Commissioner U/S 54 of C.P.C to deliver the property to the Plaintiffs.

- (c) For mesne profits to be assessed separately under order 12 Rule 20 of C.P.C. from the date of suit till the date of delivery of 1/4th share of Plaintiffs.
- (d) For court costs and such other reliefs as the Hon'ble Court may deems fit to grant under the circumstances of the case.

This suit is coming on this the 16th day of April 2026 for final disposal before Sri.Chethan R., BAL., LLB., Civil Judge & J.M.F.C. Jagalur in the presence of Sri.K.B., advocate for plaintiff and Sri.B.S., advocate for defendant No.4 to 7 and Sri.P.V.K., advocate for defendant No.1, 8 to 11 and Defendant No.3 was dead and defendant No.12 to 20 and 22 are placed ex-parte.
