

:ORDERS ON MAIN PETITION:

1. The petitioners have filed this petition U/Sec.13(3) of the Registration of Births & Deaths Act, 1969, seeking for issuance of direction to the respondent to register the date of death of petitioner No.1 her husband and petitioner No.2 to 4 father in the concerned records.
2. It is the case of petitioners that, petitioner No.1 her husband and petitioner No.2 to 4 father by name Sri Nagappa S/o Late Kallagiddappa (ಶ್ರೀ ನಾಗಪ್ಪ ತಂದೆ ಲೇಟ್ ಕಳ್ಳಗಿಡ್ಡಪ್ಪ) is permanent resident of Bilichodu village, Muggidaragihalli, Jagaluru Taluk was died on 03.04.1980 at House. However, the petitioner due to ignorance, the entry of date of death of petitioner No.1 her husband and petitioner No.2 to 4 father was not registered in the Register of Births and Deaths maintained by the respondent. As there was no entry of date of death of petitioner No.1 her husband and petitioner No.2 to 4 father the respondent issued non-availability certificate/endorsement. Now, petitioner is a need of death certificate for the purpose of obtaining the varasu. Hence, this petition.
3. Though the notices were duly served upon the respondent. The respondent remained absent, hence he placed exparte.
4. The petitioner No.3 got examined as P.W.1 and got marked Ex.P-1 to P 5.
7. Heard argument and perused the entire records.
6. The following points would arise for my consideration:
Point No 1 : Whether the petitioners are entitled for relief sought in the petition?
Point No 2 : What Order?
7. For the above points my findings are as follows:

8. **Point No.1:** The petitioners have filed this petition U/Sec.13(3) of the Registration of Births & Deaths Act, 1969 and petitioner No.1 her husband and petitioner No.2 to 4 father by name Sri Nagappa S/o Late Kallagiddappa (ಶ್ರೀ ನಾಗಪ್ಪ ತಂದೆ ಲೇಟ್ ಕಳ್ಳಗಿಡ್ಡಪ್ಪ) is permanent resident of Bilichodu village, Muggidaragihalli, Jagalur Taluk was died on 03.04.1980 at house. However, the petitioners due to ignorance, the entry of date of death of petitioner No.1 her husband and petitioner No.2 to 4 father was not registered in the Register of Births and Deaths maintained by the respondent. However, due to ignorance, the entry of date of death of petitioner No.1 her husband and petitioner No.2 to 4 father was not registered in the Register of Births and Deaths maintained by the respondent. As there was no entry of date of death of petitioner No.1 her husband and petitioners No.2 to 4 father the respondent issued non-availability certificate/endorsement. Now, petitioner needed of death certificate of petitioner No.1 her husband and petitioner No.2 to 4 father for the purpose of obtaining the heirship certificate. Hence, petitioner prayed to grant the relief claimed in the petition.

9. During the course of evidence, the petitioners have reiterated the averments made in the petition. Further the petitioner has furnished paper publication in a daily newspaper. In spite of paper publication non appeared and objected the petition. Hence, there are no impediment for issuing death certificate of Sri Nagappa S/o Late Kallagiddappa (ಶ್ರೀ ನಾಗಪ್ಪ ತಂದೆ ಲೇಟ್ ಕಳ್ಳಗಿಡ್ಡಪ್ಪ) favor of petitioner. As it is already stated that, the petitioner No.1 her husband and petitioner No.2 to 4 father was died on 03.04.1980 at Bilichodu village, Muggidaragihalli,

Jagaluru Taluk. But the same fact was not been informed to the concerned authorities. Non-informing the fact of date of death of petitioner No.1 her husband and petitioner No.2 to 4 father is bonafide one. Hence prays for condoning the delay in informing the same and for issuance of directions to the respondent to register the date of death in concerned records. This fact is clear on perusal of Ex.P.1. The oral and documentary evidence of petitioner remained unchallenged. There is nothing on record to disbelieve the case of petitioners. Considering all the above said aspects and all the materials on record, if the petition is allowed, no hardship will be caused to the other-side. Hence, I proceed to answer point No.1 in **Affirmative**.

10. **Point No.2:** Based on the above discussion, I proceed to pass the following.

:O R D E R:

The petition filed by the petitioners U/Sec.13(3) of the Registration of Births & Deaths Act, 1969 is hereby **allowed**.

The respondent is hereby directed to enter the date of death of petitioner No.1 her husband and petitioner No.2 to 4 father by name Sri Nagappa S/o Late Kallagiddappa (ಶ್ರೀ ನಾಗಪ್ಪ ತಂದೆ ಲೇಟ್ ಕಲ್ಲಗಿಡ್ಡಪ್ಪ) is permanent resident of Bilichodu village, Muggidaragihalli Jagaluru Taluk was died on 03.04.1980 in the register maintained by the respondent and after collecting prescribed fee, issue death Certificate to the petitioners.

It is needless to state that the said entry will not be conclusive evidence of the disputed date of death.
