APPLICATION FOR INTERIM BAIL

Shri Sumer Singh, Public Prosecutor for the State.

ORDER :

By way of this order, I shall dispose of an application for grant
of interim bail , filed on behalf of the applicant-accused, mentioned above.

2. Reply to the bail application for grant of interim bail has been
filed on behalf of the respondents.

3. Arguments heard.

4. Learned counsel for the accused-applicant has argued that the

accused-applicant is in judicial custody since long. It has been further argued that father of the accused-applicant has passed away on 08.09.2023 and his cremation is to take place on 09.09.2023 and the 'Tehravi' is to take place in village Mudela Khurd, Jaffarpur Kalan, South West, Delhi. As such the presence of accused-applicant at the time of cremation and 'Tehravi' is necessary to perform certain religious ceremonies and to discharge social obligations. As such, it has been prayed that the accused-applicant be granted interim bail at the time of 'Tehravi' of his deceased father and to perform religious ceremonies.

5. Learned Public Prosecutor for the State has not disputed the said fact.

6. Applicant-accused has sought the relief of interim bail for performing the 'Tehravi' of his deceased father who had expired on 08.09.2023. Police has submitted his report alongwith the death report of deceased Ishwar Silngh father of accused-applicant and statement of Jagmohan uncle of accused-applicant, in which, he has submitted that the 'Tehravi' of deceased Ishwar Singh, is to be performed on 18.09.2023.

7. After considering the facts and circumstances of the case, the prayer for interim bail is declined, however, the concerned Jail Superintendent, is directed to make special arrangement to take the applicant-accused in custody to enable him to attend the 'tehravi' of his deceased father on 18.09.2023 from 10 AM to 4 PM and thereafter to lodge him in the jail. Necessary intimation in this regard be sent to

concerned Jail Superintendent, for compliance. With these observations, the application is disposed of accordingly. Papers be tagged with main case file.
