Examination in Chief by Public Prosecutor :-

1. From 2013 November to June 2019, I had worked in Panambur P.S.

2. I assisted Investigating Officer in this case. On 30.11.2018, when I was in police station at 9.00 a.m. IO called me and asked to me with him to conduct investigation. Accused Prajwal, Arun Amin, Adithya Salian and Riyaz were in police station. IO secured two panchaas CW.13 and PW.10 to the police station. As per the instructions of IO, we covered face of Accused persons. IO, Panchaas, I, Escort and Accused left police station at 9.00 a.m. Arun Amin took us to his house situate at Thota Bengre. He produced his clothes and told the said clothes were wearing by him at the time of incident. He

produced on white jeans pant, mix colour full sleeves shirt and brown colour inner wear. A mahazar was prepared and clothes were seized. As per the instructions of IO, I wrote mahazar. The said mahazar was prepared between 9.45 and 10.30 a.m. I now see Mahazar Ex.P19, it bears my signature. Signature of witness is marked as Ex.P19(b). I can identify clothes. Witness identifies clothes MO.6 to 8. While conducting mahazar photograph was taken. I now see photograph Ex.P20.

2. From there Accused Riyaz took us to his house which is in a distance of 5-10 minutes from there. He produced one mixed colour check lungi, one cream colour shirt and one blue colour inner wear. As per the dictation of IO I wrote mahazar between 10.45 and 11.30 a.m. and seized clothes. I now see Mahazar Ex.P21, it bears my signature. Signature of witness is marked as Ex.P21(b). While conducting mahazar Ex.P22 photograph was taken. I can identify clothes. Witness identifies clothes MO.9 to 11.

3. From there all the four Accused persons took us to spot stating that they would show the spots. They took us to spot situate at Halivebagilu, Thota Bengre, Sea shore and showed the spots. As per the spots shown by the accused, mahazar was prepared between 11.45 and 12.45 noon. I now see Mahazar Ex.P23, it bears my signature. Signature of

witness is marked as Ex.P23(b). While conducting mahazar Ex.P24 photographs were taken.

4. Then we returned to police station.

5. I can identify Prajwal, Arun Amin, Adithya Saliyan and Riyaz. Today four accused persons present before the Court. Witness identifies from right 1st person as Prajwal, 2nd person as Adithya Saliyan, 3rd person as Riyaz and 4th person as Arun Amin. On enquiry with them, they reveal their names as Prajwal, Adithya, Abdul Riyaz and Arun Amin.

Cross-examination by Sri. RKA Advocate for accused No.1:-

6. It is false to suggest that Accused persons did not produce MO.6 to 11 under Ex.P19 and 21. It is false to suggest that Ex.P20 and 22 are not pertaining to the house of Accused Arun Amin and Riyaz. It is false to suggest that Accused Prajwal, Arun Amin, Adithya Saliyan and Riyaz did not take us to spots and did not show spots. It is false to suggest that Ex.P19, 21 and 23 were prepared in police station. It is false to suggest that signature of panchaas were taken in police station. We have not taken signature of neighbors and inmates of the house of Arun Amin and Riyaz on the mahazar.
