JUDGMENT

(Delivered on 07th day of December, 2018)

The accused voluntarily pleads guilty. Therefore, the accused is liable to be convicted. The accused submits that he is only earning member of his family. He further submits that this is his first offence. Therefore, the accused prayed for leniency. Considering submissions of the accused, in my view, lenient view will have to be taken. Hence, I pass the order :

ORDER

(01) The accused namely Nagesh Shantaram Bandgar, R/o.: Behind Vasantrao Naik High School, Nul Bazar Chowk, Solapur is convicted for the offence in contravention of the section 8 (c) punishable under section 27 of the Narcotic Drugs Psychotropic Substances Act, 1985 vide section 252 of the Code of Criminal Procedure and he is sentenced to suffer simple imprisonment for 07 (Seven) days.

(02) The sentence passed in C. C. Nos. 450/PS/2018 of Bandra Railway Police Station and C. C. No. 37/PS/2018 of Mumbai Central Railway Police Station shall run concurrently.
