The brief facts of the case are that on 24.06.2018, police party headed by HC Sukhdev Singh was present near Green Avenue Colony, main road, Barnala in connection with nakabandi and at about 12.30 am, a swift car bearing registration no.HR-33C-6742 came from the side of Court Chowk, Barnala, which was signalled to stop with the help of torch light. The driver of the car stopped the vehicle 500 yards behind after switching off the light of the car. The driver alongwith his two companions ran away towards different directions. On checking of car, 120 bottles of country made liquor, make CASH MALTA, was recovered in 10 cartoons, from the car. On further checking of car, no registration certificate of the said car could be found. On these allegations, the FIR was registered. The accused/applicant was nominated in the present case on the interrogation of co-accused Kuldeep Singh.
4. The bail application of co-accused Kuldeep Singh was dismissed by the undersigned on 06.07.2018 but the co-accused was granted pre-arrest bail by the Hon'ble Punjab & Haryana High Court on 25.09.2018. Therefore, in view of the circumstances narrated above, without commenting upon merit of

the case, the accused/applicant is granted interim pre-arrest bail and arresting/investigating officer is directed to release the applicant/accused on bail in the event of his arrest. The applicant/accused shall abide by the terms and conditions as incorporated under Section 438 (2) Cr.PC.
