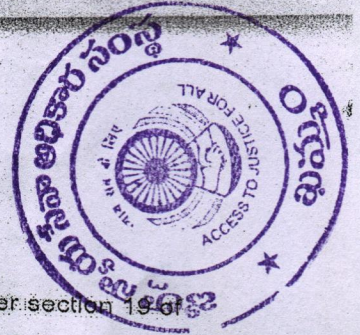

Brief facts of the Petition: Claim filed for compensation of Rs. 5,00,000/-  
account of. Death of late Eureka Bakkamma  
08-01-2021 in the limits of P.S. D Town, mityalaguda.

This petition was referred to the Lok Adalat by the Motor Accidents Claims Tribunal, Khammam.

This petition coming before Lok Adalat today for final settlement in the presence of the petitioners, Respondents and of Sri T. Ramesh Babu, Advocate for claim petitioner and of Sri B. Saikanth, Advocate for the Respondent No. 2. The respondent No. 2 came forward to indemnify the Respondent No. 1. Hence, there is no separate order against Respondent No. 1. Both the parties to the petition have agreed for amicable settlement and filed terms of compromise with free will and volition. Hence, the following award is passed as per the settlement arrived at between the parties.



# AWARD

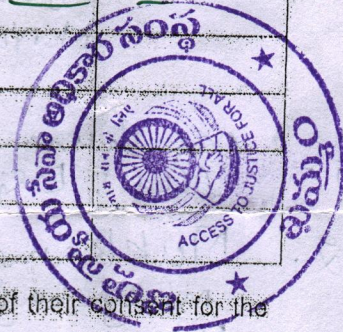
1. After negotiations and conciliation between the parties, the claim is settled at Rs. 2,80,000/- (Rupees Two lakhs eighty thousand only) towards full and final settlement of the claim amount without interest and costs and is hereby awarded accordingly under Section 21 of the Legal Services Authorities Act, 1987.

2. If the Respondent No. 1 does not deposit the amount within one month from today, the amount so awarded shall carry interest at the rate of 7.5% per annum from the date of this award.

3. The Court Fee paid shall be refunded to the petitioner.
