Judgement

1. It is the case of the prosecution that the accused in this case committed the offence punishable u/s. 66(1)(B) & 85-1 of Prohibition Act.
2. On submission of police report under section 173(2) of Cr.P.C., the copy of the police report and other documents were furnished to the accused person(s) under section 207 of Cr.P.C. Thereafter, the substance of the accusation was stated to the accused person(s) and asked whether he pleads guilty or has defence to make. Thereon, the accused pleaded guilty to the charge and submitted a pursis in this regard.
3. The accused pleaded that it is voluntary admission of guilt and it is the first such offence committed by the accused. The commission of the offence is repented by the accused and pleaded for mercy.
4. Looking to the facts of the present case, circumstances of the accused and voluntary admission of guilt on the part of the accused, considering the plea of the accused for **plea bargaining**, the following order is passed in the interest of justice.
5. Accordingly, the present plea bargaining application of the accused in this case is allowed and I deem it fit to make the following order maintaining the status of the accused acquittal.

ORDER

1. The accused is convicted u/s. 252 of Cr.P.C. and is sentenced pay total fine Rs.200/- (Rupees Two hundred only). In default of payment of fine, to undergo simple imprisonment for 2 days.
2. This Case shall have the effect of acquittal.
